4. The bidders are not permitted to withdraw their bids once the EMD is deposited by them. In case of non-participation of bidders in the auction, the EMD shall be forfeited. 5. Bidder can increase their offer in multiplication of Rs.5,000/- (Rupee Five Thousands).
